- 6. The District Fire Officers are requested to supply the required number of Xerox copies of **prescribed proformae** for Application, Inspection report and No Objection Certificate of Provisional /Occupancy/Renewal.
- 7. The District Fire Officers are requested to ensure that Station Fire Officers shall maintain minimum riding crew while conducting the inspection.
- 8. The Committee nominated at Para 1 above is requested to review the implementation of above instructions and submit a detailed report in the 1st week of July, 2015.
- 10. In view of the above, the Regional Fire Officer, Central Region, Hyderabad, all the District Fire Officers, Asst. District Fire Officers and Station Fire Officers are instructed to implement the orders immediately.
