In continuation of the reference 5th cited, the attention of District Fire Officers is drawn to the references 2nd to 4th cited, where in they were delegated powers for issuing Provisional/Occupancy NOCs to various types of Non-High rise occupancies. These powers are delegated beyond the mandate of the Fire Service Act.

- 2). The officers are therefore, instructed to restrict to issue provisional/occupancy NOC only to the premises covered under Section 13 of Fire Service Act only i.e. "buildings of more than 15 meters height for commercial/business purpose, 18 meters and above height for residential purpose, and buildings of public congregation like schools, cinema halls, function halls, religious places, which are more than 500sq. meter in plot area or 6 meters and above in height."
- 3). In view of the above, all the RFO/DFO/ADFO/SFOs are instructed to not to issue any provisional/occupancy NOCs to the Industrial Buildings which are not covered under Section13 of Fire Service Act, 1999, and which are received under TSi-PASS and return those applications stating that the occupancy is not covered under Section 13 of Telangana Fire Service Act, 1999 and are exempt.

4). All the Fire officers, in Telangana state are requested to follow the above orders with immediate effect.
