This case is coming before me on 4-04-2012 for final hearing in the presence of Smt.Koma Latha, Public Prosecutor for complainant and of Sri Papa Reddy, Advocate for Accused No.1 and of Sri K.Krishna, advocate for Accused No.2 and upon perusing the material papers on record; upon hearing both sides and having stood over for consideration till this day, this Court delivered the following:

:: J U D G M E N T ::

This case is referred from the Chief Metropolitan Magistrate, Hyderabad for adjudication on Plea Bargain. Petitioner/ accused is present. Verified with regard to the voluntariness of the accused in CAMERA, in filing this application. I am satisfied with the answers given by the petitioner/accused that his application for plea bargain is voluntary.


The accused and other stake holders are present. Investigation officer identified the accused and represented that the accused is first offender and that he is not convicted in any similar offence as per section 265-B of Cr.P.C. MSD arrived by all stake holders under my supervision and signed by all stake holders (vide MSD report annexed). Considering the nature of the case and the terms

After having heard the accused and proposed sentencing in the quantum of sentence prescribed for the offence/ other mitigating circumstances, this plea bargain court passes judgments under section 265-F of Cr.P.C. as follows:

The A1 and A2 pleaded guilty for contravention provision U/Sec. 31 Fire Service Act, 1999 and to pay fine of Rs.10,000/- each and in default SI for of one week.

The office is directed to send the duly indexed record to the referral court under intimation to the Chief Metropolitan Magistrate, Hyderabad.
