ORDER:

In the G.O.1st read above, Government had accorded permission to the Director General, A.P. State Disaster Response & Fire Services Department to collect User charges for under taking inspections of Multi Storeyed Buildings and Hazardous premises towards the issuance of No Objection Certificate and other Fire Safety Measures. .

2. The Director General, Telangana State Disaster Response & Fire Services, Hyderabad in the letter 2nd read above, has stated that, in the G.O. first read above, there is no provision to collect User Charges for conducting the Fire Audit in the Multi Storeyed Buildings for issuance of No Objection Certificate from Fire Service Department and requested for inclusion of the two items in the said G.O.

3. Government after careful examination, hereby issue the following amendment to the orders issued in the G.O.Ms.No.71 Home (Prisons.A) Department, dt.01-04-2010:-

AMENDMENT

In the para-6 of G.O.Ms.No.7, Home (Prisons.A) Department, dated 01-04-2010, after Sl.No.7, the following items shall be added:

8.	Conducting Fire Audit in each building <u>below</u> 15 mtrs height	RS.25,000/-
9.	Conducting Fire Audit in each building <u>above</u> 15 mtrs height	RS.50,000/-

Note: The above amounts collected shall be remitted to the Government Treasury.

4. The Director General, Telangana State Disaster Response & Fire Services, Hyderabad shall take action accordingly.

5. This order is issued with the concurrence of Finance (EBS.VI) Department, vide their U.O.No.12620/513/A1/EBS.VI/2016, dated 22-10-2016.
